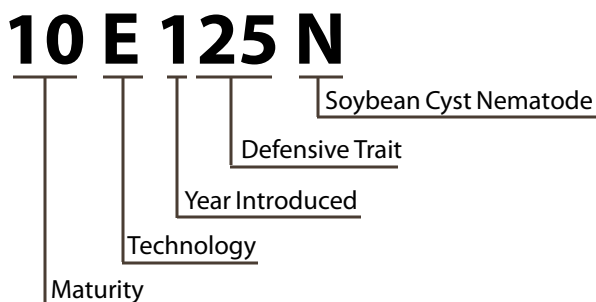

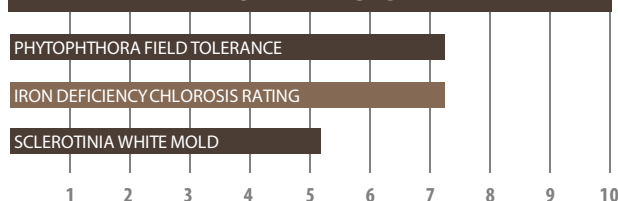

#### SEED USE AGREEMENT

MS TECH and its suppliers have a substantial investment in the development and production of this seed, and in the use of subsequent production of Seed.
