DIRECTIONS FOR USE

DISEASE CONTROL - Spirato: provides disease protection against seedborne and soilborne fungi that cause seed decay, damping-off, and seedling blight. DISEASE CONTROL - ST-Methyl: improves disease control and provides systemic protection. DISEASE CONTROL - Precinct: at the rate noted above provides systemic protection against Pythium

INSECT CONTROL: Senator 600 FS used at a rate of 1.6-3.2 oz /100 lb seed provides early season protection of seedlings against injury by seed corn maggot, bean leaf beetle, and aphids in soybeans, and wireworm, bean leaf beetle, imported fire ant, and aphids in other leguminous seed- and pod- vegetables. Higher rates provide increased length of protection and are more effective against heavy insect pressure.
